Allen Repeats as Constitutional Essay Champion!

Scio Central School Senior Alannah Allen won a county-wide Constitutional essay contest sponsored by the Allegany County Bar Association. This is the second consecutive year Alannah has won this competition.

This year's topic was "Free Press, Free Speech, Free Society." Alannah's beautifully written essay bested others from around the county and earned her a \$300 cash prize, as well as an invitation to the Law Day Luncheon at the Allegany County Court House.

Changes to STAR: Exemption or Credit?

If you currently receive your STAR benefit as a reduction on your school tax bill (the STAR exemption), you may receive a greater benefit if you switch to the STAR credit to receive a check instead.

Q: What is the difference between the STAR exemption and the STAR credit?

A: The STAR exemption appears as a direct decrease on your annual school tax bill. Receiving the STAR credit means you would pay the entire amount of your annual school tax bill then receive a check from New York State for your STAR benefit.

Q: What are the recent changes in the law affecting my STAR benefit?

A: Recent changes in the law beginning in April 2019:

The value of the STAR credit savings may increase by as much as 2% each year, but the value of the STAR exemption savings will not increase.

The income limit for the Basic STAR exemption is now \$250,000.

Q: Is changing from the STAR exemption to the STAR credit mandatory?

A: It depends upon your income level. If your income is more than \$250,000, you must switch to the STAR credit to continue receiving a STAR benefit. If your income is \$250,000 or less, you have the option to switch.

Q: What is the benefit of switching from the STAR exemption to the STAR credit?

A: In future years, the amount of your STAR exemption will remain the same. However, if you receive the STAR credit, your STAR benefit may increase as much as 2% every year.

Keep in mind that if your property taxes are paid through an escrow account, the switch may have an effect on your monthly mortgage payment. Contact your mortgage lending company if you have any questions.

Q: How do I switch from the STAR exemption to the STAR credit?

A: To switch to the STAR credit:

Notify your assessor to withdraw from the STAR exemption by completing Form



RP-496 Application to Renounce Previously Granted Exemptions, which can be downloaded by visiting https://www.tax.ny.gov/pdf/current forms/orpts/rp496 fill in.pdf.

Visit https://www.tax.ny.gov/pit/property/star/default.htm and follow the directions to register for the STAR credit online.

The SCS Scholastic Challenge Teams have had a very exciting and busy year! They had a later start, but came out strong with our two-man team, sophomore Jeb Broach and freshman Shawn Patrick, winning the Varsity Division in the Regionals held at Portville Central School on Saturday, April 6.

Our JV Team, which was comprised of eighth graders Will Broach, Derek Ketchner and Jordan White and seventh grader Greg Wesche, also won their Division.

Both teams won all of their preliminary matches with their first losses coming in the finals, where both teams came through with a win in the double elimination tournament. Combined, the two teams competed against 35 other Scholastic Challenge teams throughout the day. With the win, both teams also qualified for the National Competition.

With fundraising, donations and school support, the two teams went to Washington, D.C. on May 30 through June 2. The six students actually combined and competed as one JV team at Nationals against students from around the country. At Nationals, teams compete in six preliminary matches. If you win four, you continue on to the finals on Sunday. Unfortunately, we won three and lost three, so we came up short.

Art Teacher and Scholastic Challenge Advisor Tammy Straight said, "This was our third time attending the National Competition. The team had a great time and it was a great learning experience."

She added, "Thank you to everyone, to the teachers, parents, community, and for all of the support from the school. These kids love this, it is knowledge and they thrive on it, (and) I know they appreciate all of the support from you!"

Mr. Childs has announced new college credit courses will be offered in business beginning in the Fall of 2019. An exciting addition to next year's Scio curriculum is a half-year *College Business* 1500 class and a half-year *College Finance* class for a total of six college credits.

According to Mr. Childs, "This class is everything real life from retirement planning to succeeding in the world of work. Many people have said schools need to teach more of this type of material -- well, here it is! Other college offerings in business include a half-year of *College Economics* and a full year of *College Accounting*."

Scio students can now graduate with 12 college business credits through Jamestown Community College. These courses are available to all SCS juniors and seniors. SCS sophomores wishing to try for college credit must meet these criteria: a. 80% average for high school; b. fifteen years old by the end of the course; c. approved by parent (s) and guidance counselor.



- (2) Write the amount of current income each household member receives, before taxes or anything else is taken out, and indicate where it came from, such as earnings, welfare, pensions and other income. If the current income was more or less than usual, write that person's usual income. Specify how often this income amount is received: weekly, every other week (bi-weekly), 2 x per month, monthly. If no income, check the box. The value of any child care provided or arranged, or any amount received as payment for such child care or reimbursement for costs incurred for such care under the Child Care and Development Block Grant, TANF and At Risk Child Care Programs should not be considered as income for this program.

Great News, AGAIN!

Scio Central School is pleased to announce that we will continue to participate in the Breakfast and Lunch program, Community Eligibility Provision (CEP) for the 2019-2020 school year.

What does this mean for our students? Every child will receive a healthy breakfast and lunch for FREE. Yes, we mean FREE.

Applications

All families are encouraged to continuing filling out the Household Income Form. The form will be sent home at the beginning of the school year, or can be picked up in the office or cafeteria. We are asking for every family to complete a form. Qualifying families will help us to continue receiving special grants and funding throughout the school district.

All information is strictly confidential.

ID Cards

All students and staff will be issued an ID card with their picture and ID bar code on it. Cards will be provided by the school when pictures are taken. Students in grade 5-12 will be able to use the finger scan system for any purchase made in the cafeteria.

Pre-Paying on Account

As both breakfast and lunch are free the only money needed will be for ala carte items, such as extra milk or a second meal. It is best to prepay on your account by giving the cashier money ahead of time. Parents may send in a check or money in an envelope or stop by the school to make a payment. All money will be added to your student's account and the cashier will access the account at the time of purchase.

Ala Carte Sales

Student desiring ala carte items, such as extra milk or a second meal must pay cash or have money in their meal account. <u>Students will not be allowed to charge ala carte items</u>.

Community Eligibility Provision Program

The Scio Central School district is committed to providing every student enrolled with all the tools they need to succeed, including nutritious meals that everyone can enjoy. The Community Eligibility Provision program is offered through the New York Child Nutrition (CN) Department and allows the district to provide a free breakfast and lunch to every student!

Here are some questions and answers rearding Community Eligibility Provision program.

How does this program work?

The New York State Child Nutrition (CN) Department began this program several years ago with federal funding backing the program. School districts must be eligible based on their specific

poverty rates and have to apply to the NYS CN Department for approval.





Does the school provide a second breakfast or lunch for free?

No. The school only gets reimbursed from New York State on the first breakfast and lunch served. Families are responsible for payment of a second meal.

Can children still bring their lunch?

Yes. However, if they buy milk, it is the families' responsibility to pay for the milk.

How will ala carte items (pizza, nachos, chips, etc.) be handled?

As in the past, families will continue to pay for a la carte items. Available a la carte items are shown on page 11.

Will the school district request a household application?

Yes. Other federally funded grants that the district receives are based on the district's poverty levels. This data was gathered through the cafeteria free and reduced applications process. In order to continue to receive such grants, the income information still needs to be gathered. We encourage all families to submit applications as these play a crucial role I the district maintaining these grants!


